It is further agreed that this waiver, release and assumption of risk is to be binding on my heirs and assigns. I and my sponsored guests or dependents agree to indemnify and to hold the above persons and entities free and harmless from any loss, liability, damage, cost, or expense which they may incur as the result of my death or injury or property damage that I may sustain while participating in said activity (ies).

Following the rules and guidelines that have been established by Douglas Aquatics, Inc. will minimize the risks inherent to aquatic activities and decrease the chance of injury. I, the undersigned, understand the Facility Guidelines and that there are limitations to my use of the Facilities. I undertake to explain the Facility Guidelines to my sponsored Dependents and guests, and to assure their compliance with them.
